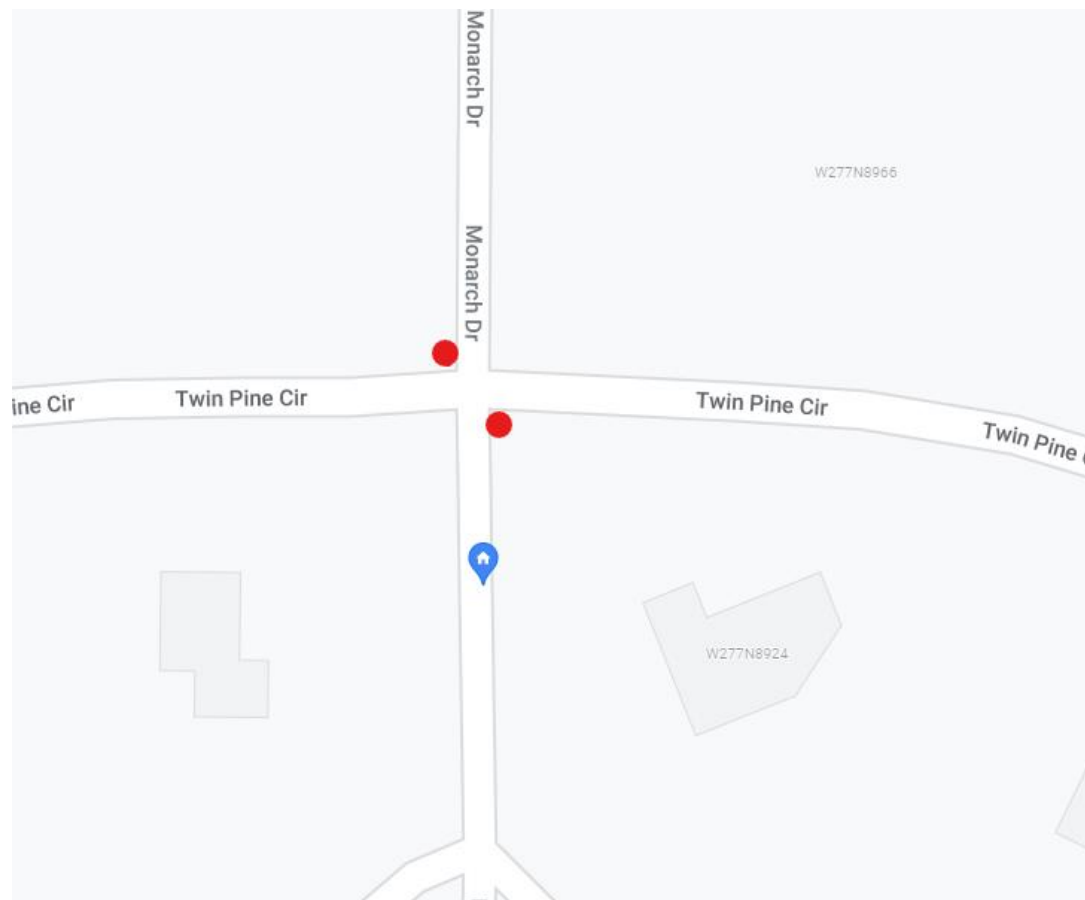
Hi Joe,

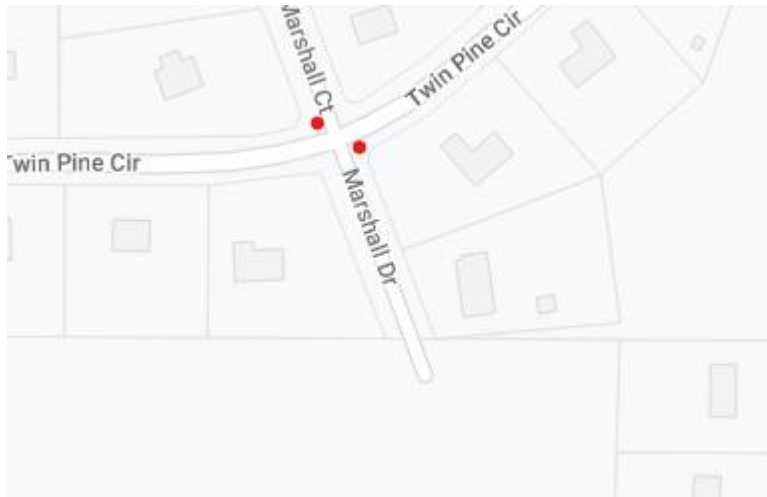
