## **An Election for the Village President and Village Trustees of the Newly Incorporated Village of Lisbon**

WHEREAS, the Village of Lisbon has been officially incorporated into a Village on February 13, 2023 by formally receiving notification from the Department of Administration.

NOW, THEREFORE, I, Meg Wartman, County Clerk for Waukesha County, Wisconsin, pursuant to Wisconsin Statute 66.0213(4)(a), an election shall be called by the County Clerk, Tuesday, April 4, 2023, for the first election of the newly incorporated village, whose boundaries are provided in the Articles of Incorporation, said boundary information can be obtained from the Village of Lisbon Clerk, Elisa Cappozzo Katch. The term of office for the Village President will expire on April 21, 2025. Two Village Trustee seats terms will expire on April 21, 2025. Two Village Trustee terms will expire on April 15, 2024. The four trustees elected at the first election shall serve the following terms:

The term of office of the two candidates receiving the highest number of votes in the first election shall be two years ending with the spring election in 2025.

The term of office of the two candidates receiving the third and fourth highest votes shall be for one year ending with the spring election in 2024.

Thereafter, the term of office of all Trustees shall be two years with two trustees being elected in even numbered years and two trustees being elected in odd numbered years.

Circulation of nomination papers shall be filed no later than 5:00 p.m. on Monday, March 20, 2023, in the office of the Lisbon Village Clerk, W234 N8676 Woodside Road, Lisbon, WI.

The polling locations for this election shall be as follows:

- Wards 1, 6, 7 at Lisbon Village Hall - W234N8676 Woodside Road, Lisbon 53089

- Wards 4, 5 at Richard Jung Memorial Fire station - N54W26455 Lisbon Road, Pewaukee 53072  
Election Officers: Teresa Pelt, Susan Rechcygl, Mary Knapp

This election shall be held, conducted, canvassed, and returned in accordance of law. The seating for the Village of Lisbon Village President and Village Trustees are set by the Village Charter Ordinance.
